# MRES – ELECTRIC SYSTEM ASSESSMENT

Jeff Becthold, from Missouri River Energy Services, presented an Assessment of the City of Paullina Electric System. Becthold stated the following items need to be addressed:

- 1. Substation inspections and breaker maintenance.
- 2. Tree Trimming.
- 3. Secondary wires mounted higher than the primary.
- 4. Trancloser change outs need to be replaced.
- 5. Upgrade poles and cross arms.
- 6. Transformer change outs.
- 7. Mapping of the system.

Bechtold stated we have adequate materials for normal operation and maintenance, need to look at converting to an all underground system, purchase a digger derrick truck and make sure we have staff to operate the system.

### **BALL DIAMOND LIGHTS**

Jason Eygabroad, from Beck Engineering, presented the preliminary plans and specs to replace the lights at the city ball diamond. The City of Paullina will remove the existing lights and poles and bore the new service. All other items will be completed by the contractor.

Murphy moved and Honkomp seconded the motion to set the bid letting for the Ball Diamond Light project for October 14 at 2:00 p.m. at City Hall and the Public Hearing will be held on October 18, 2021 at 5:30 p.m. to award the bid. Motion carried by all ayes.

RML ARCHITECTS, LLC

Mike Neswick, from RML Architects, LLC, presented the updated Paullina Emergency Services Building Contract. The pricing and contract details were clarified. The Paullina Fire Department will be contacted to discuss a location, features of the building and funding.

Heeren moved and Murphy seconded the motion to reconsider the RML Contract at the next meeting on September 20, 2021.

**NUISANCE UPDATES** 

The Nuisance Violation Hearings for the properties on East Broadway and 317 S Maple were held at the O'Brien County Courthouse on September 7, 2021. The judge ruled in favor of the City of Paullina in both cases.
